The specification provides for the design, installation, replacement, servicing, and repairs to smoke control systems. Members will also have the option for misting systems to be installed where appropriate.

## 3 Fire Alarms, EM Lighting & Extinguisher

The specification provides for the installation, replacement, servicing and repairs to fire alarm systems, emergency lighting systems, periodic testing and inspection of fire safety installations, the supply of fire extinguishers and fire blankets and the replacement of smoke detectors.

### **4 Door Entry & Access Control**

The specification provides for the installation, replacement, servicing and repairs to Access Systems.
