CHIC's framework is for the supply of timber fire door sets with optional supply and installation.

## TIMBER FIRE DOOR SETS

**Standard Size Door** – The door itself is a standard size and small variances in the size of the aperture where the door set is to be fitted can be accommodated through adjustments to the frame and/or through the use of appropriate packings, such adjustments **MUST** meet any standards approved under the BWF Certified Scheme.

**Bespoke Size Door Set** – The door itself is not a standard size and has to be manufactured to a bespoke size prior to having an approved frame added to complete the door set.

## INSTALLATION OF MATERIALS

All preparation, installation and finishing works shall be completed in accordance with the advice, requirements and good practice recommended by the Glass and Glazing Federation Code of Practice for Window Installation Safety (GGF / BPF COP3 – Recommended Practice for the installation of Windows), and comply with current Building Regulations.

Survey of properties and design of the windows and doors will be undertaken by the contractor in conjunction with the materials supplier.
