This is a 4-year framework of suppliers for Asbestos Abatement Services. Contracts are available to members via mini-competition or direct call off (subject to business case approval).

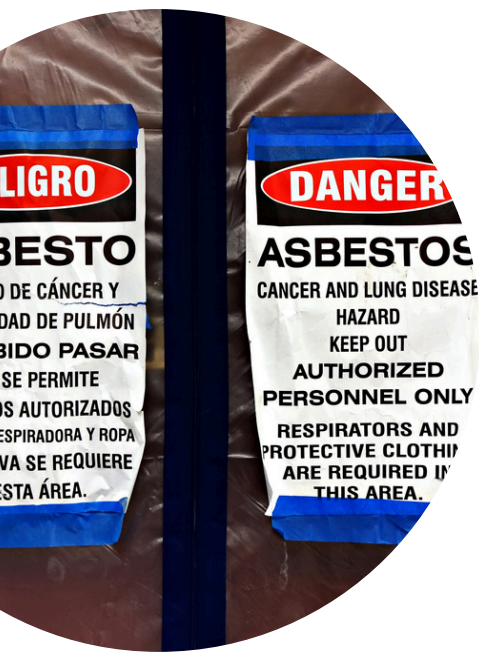
The majority of work types which will be undertaken are asbestos removal work, but limited amounts of asbestos management work will also be required, such as encapsulation.

Typical work areas may include removal of the following items:

- Fascia, barge or soffit board;
- Roof tiles;
- Downpipes or gutters;
- Thermoplastic floor tiles;
- Plasterboard ceiling or wall lining with artex; and;
- Pipe insulation.

Contractors must hold:

- 3 Year HSE Asbestos Removal License
- Membership of Asbestos Removal Contractors Association – ARCA
- All operatives and site management to hold CSCS cards
- ISO 9001
- ISO 14001
- SSIP Membership (usually CHAS/Constructionline etc.)
- EA Waste Carriers License
