CHIC's Newbuild Framework provides a comprehensive solution to deliver all types of development related works and services to help tackle the housing shortage. It caters for a wide range of project types, from small infill and garage sites to large estate regeneration projects including newbuild, refurbishment/retrofit and cross subsidy housing for sale. It also provides MMC solutions including fully modular, frame & panel and turnkey options.

The framework addresses the specific needs identified through member consultation, including a longer term duration, MMC options and support, consultancy services, a solution for larger regeneration projects, the use of standard contracts, BIM integration and a focus on collaborative and social value outcomes.

Members can access the framework via mini-tender or direct award, offering flexibility in procurement processes. The framework has been carefully considered so that it aligns with the Government's recommendations for Constructing the Gold Standard, emphasising quality, innovation and sustainability.

A dedicated Framework Core Group is established to facilitate learning, standardisation and collaboration among stakeholders to ensure that the sector is working towards the same goal, delivering new homes efficiently.
